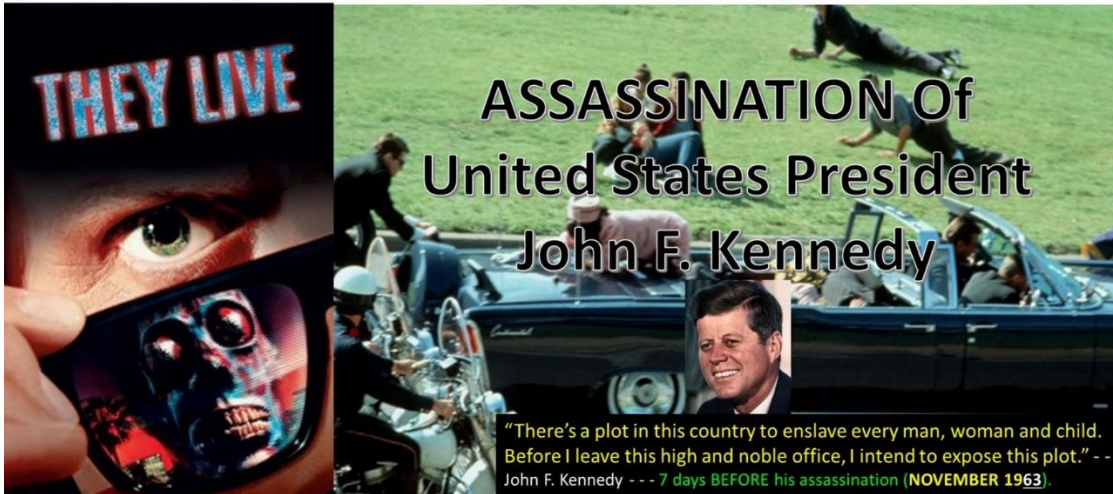

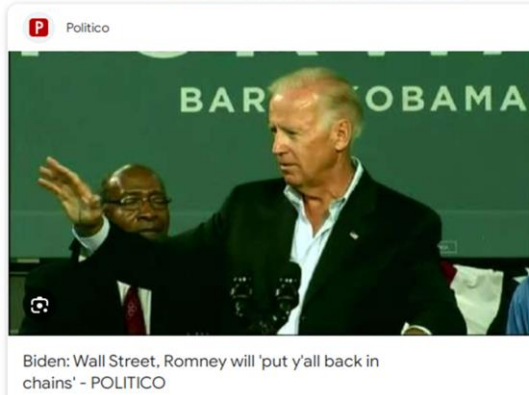

**Southern states**

"Black Codes" in the antebellum South strongly regulated the activities and behavior of blacks, especially free Blacks, who were not considered citizens. Chattel slaves basically lived under the complete control of their owners, so there was little need for extensive legislation. "All Southern states imposed at least minimal limits on slave punishment, for example, by making murder or life-threatening injury of slaves a crime, and a few states allowed slaves a limited right of self-defense."<sup>[8]</sup> As slaves could not use the courts or sheriff, or give testimony against a white man, in practice these meant little.

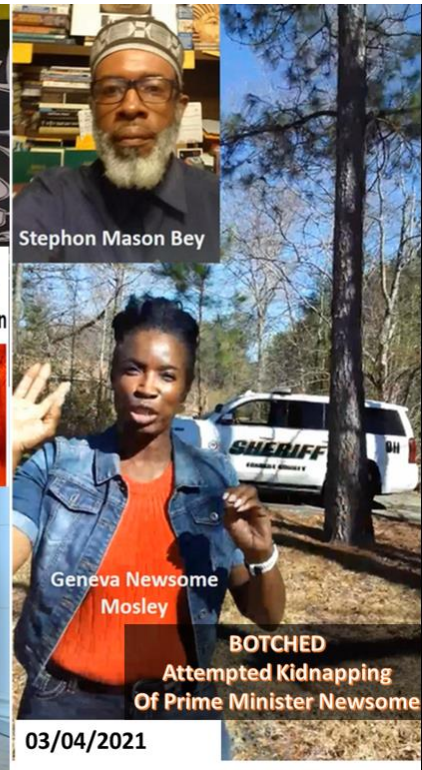

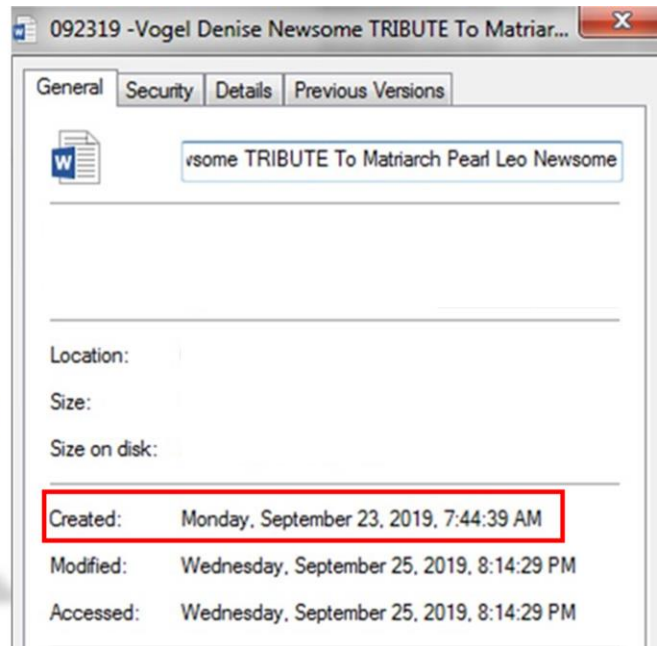
