My name is Vogel Denise Newsome and I am Prime Minister for the Chickasaw Tribal Nation ("CTN") and Utica International Embassy ("UIE"). Due to the THREATS and continued CONSPIRACIES, etc. to have me Kidnapped and / or Murdered / Assassinated as well as Citizens and / or Supporters of our Nation and Embassy, please find the *above-referenced* document at the following link(s) - - **IMPORTANT TO NOTE:** Nazism / White Supremacy / Zionism . . . promote War Crimes, Crimes against Humanity, and other Atrocities, etc. that are NOT pretty! The EVILS / WICKEDNESS . . . of such are a REALITY! NOTICE IS HEREBY ISSUED: At this time the Staff / Members of our Legal Team *will remain anonymous* in our good-faith efforts to shield / protect them from unlawful RETALIATORY attacks [*as explained in filing*] as well as further War Crimes, Criminal Acts and other Atrocities, the United States of America’s / United States’ Officials . . ., their Presidents, their Legal Counsel Baker Donelson Bearman Caldwell & Berkowitz and their Co-Conspirators (as Lloyd’s of London and their Syndicate Member), etc. have become accustomed to! It has been brought to our Nation's attention that the following War Crimes, Human Rights VIOLATIONS / THREATS . . . (and more) from United States TERRORSIST Groups (as their *so-called* Federal Government [a "privately held company"], *White Supremacists*, *Ku Klux Klan Members* and *Jews / Zionists* . . .) DOMESTIC Terrorism persist as:

- (a) Poisoned / Contaminated WATER Supply;
- (b) Unlawful SEIZURES Of Prison / Detention Center;
- (c) Unlawful SEISURES of Schools / Colleges / Universities;
- (d) Unsafe Road / Infrastructure Conditions;
